Program Overview

THIS COURSE WILL COVER STRATEGIES TO ADDRESS THE OFTEN UNRECOGNIZED RISKS RELATED TO TECHNOLOGY IN YOUR PRACTICE, SPECIFICALLY ELECTRONIC HEALTH RECORDS, SOCIAL MEDIA, AND TELEPSYCHIATRY. THE FOCUS WILL THEN SHIFT TO THE GREATEST LIABILITY RISK EXPOSURES FOR PSYCHIATRISTS – TREATING PATIENTS WITH SUICIDAL BEHAVIORS AND PSYCHOPHARMACOLOGY. THERE WILL BE AN EMPHASIS ON SUICIDE RISK ASSESSMENT, PRESCRIBING CONTROLLED SUBSTANCES, AND LIABILITY TO THIRD PARTIES WHEN PRESCRIBING. STRATEGIES FOR REDUCING LIABILITY RISKS TEND TO ENHANCE PATIENT SAFETY. THE COURSE WILL CONCLUDE WITH AN EXTENSIVE QUESTION AND ANSWER SESSION, AND PARTICIPANTS WILL BE GIVEN THE OPPORTUNITY TO SUBMIT QUESTIONS IN ADVANCE OF THIS COURSE.
